Approval of 2020 Annual General Meeting Minutes

Motion to approve proposed by Kathi Loughran, approved by Reza Khoshdel, seconded by Sharon Stoute. None opposed. Motion carried.

W.R.C.A. 2020-2021 Highlights

Presented by Kathi Loughran, President

- Emphasis on communicating with community members to keep everyone updated via the twiceyearly publication of the West Rouge Life magazine, monthly e-newsletters, frequent website updates, neighbourhood signage and WRCA Facebook page.
- The WRCA hosted an all-candidates meeting jointly with the CCRA and HCCA in advance of the federal election which was well-attended and an opportunity to get to know the candidates better.
- WRCA continued its advocacy to oppose the bio-gas plant proposal for 633 Coronation through the fall and winter, which resulted in the withdrawal of the application in 2021. Thanks to Jennifer McKelvie for her advocacy also.
- Ongoing efforts to generate membership revenue via community lawn signs and website. WRCA donations to community events have decreased as events have been stalled due to the pandemic.
- Advocated for Section 37 funds to be used for 'Welcome to West Rouge' signage on Port Union Road and sign board in Fanfare Park which are scheduled to be installed in Fall 2021/Spring 2022.
- Continued discussion with Parks Canada regarding concerns with illegal parking, littering, safety at Rouge Beach.
- Advocated for a proposed boardwalk route option that would have the least impact on adjacent homeowners.
- Regular communication is being maintained around the upcoming release of the Detailed Impact Assessment regarding the proposed improvements for the boardwalk.
- Impact of Covid-19:
 - For a 2nd year, most street captains were not able to canvas which resulted in reduced membership revenue but revenue was in line with last year
 - West Rouge Life magazine advertising revenue was lower than previous years which was expected due to the impact of the pandemic on local businesses. The advertising revenue pays for the magazine publication expenses.
 - Donations have decreased as many events have been postponed but the board is ensuring that the association is in a strong position for future donations
 - Implementation of a virtual neighbourhood watch program has been delayed as in-person registration is preferred so most likely will not happen till early next year when hopefully pandemic restrictions are lifted
- A few changes on the board took place this last year with three board members stepping down Ken Kuzmich, Deb Kravis, and Gita Viswanathan. It is the volunteer work of the W.R.C.A. Board of Directors, Area Coordinators, Street Captains, and Diane Sherlock that ensures that the community association remains strong.

Financial Report

Financial Statements presented by Sharon Stoute, WRCA Treasurer

Financial update – Income & Expense

- Overall revenues decreased by \$2.3K in F2021
- Membership revenues have increased by \$270
- Advertising revenues for West Rouge Life were down slightly

- Cash was invested in GICs total earned interest (paid and accrued), down from previous year
- Expenses decreased \$3.2K which includes the annual depreciation of \$2.5K per year for the electronic sign on Island Road.
- Donations to events decreased by \$830
- Bank charges decreased by \$45 or 22%. PayPal charges increased by \$35 or 8.3% due to the increased number of transactions.
- Operating costs were down by \$2K
- West Rouge Life Magazine production costs slightly exceeded revenues
- Financial year ended with a \$1.6K net surplus

Financial Update - Balance Sheet & Statement of Investment

- As at Sep 30th WRCA had a cash balance of \$22.2K and \$40.7K in GICs
- Accrued liability of \$6.5K is for issued cheques outstanding as at Sep 30th

Membership Deposits

A chart was shared to demonstrate the monthly flow of membership fees in F2021 back to F2018, and to illustrate the impact of Covid-19 on membership fees.

Membership Fees and Advertising Revenue

There has been a significant increase in the use of PayPal for both membership fees and advertising payments since F2018, with Cash/Cheque and PayPal being almost equally distributed in F2021.

Kathi Loughran proposed a motion to approve the Financial Report, seconded by Larry Whatmore. None opposed. Motion passed.

Election of W.R.C.A. President & Board of Directors

Larry Whatmore, Director of Membership, chaired the election and advised that the W.R.C.A. Constitution requires that the Board of Directors be retired before proceeding with the elections, and the President be elected first, followed by all other directors as a group.

Kathi Loughran will be stepping down as President after 2 years, but will stay on in the role of Past President. Kathi was thanked for her leadership especially during the challenging times of the pandemic.

Larry declared the 2020 Board of Directors to be retired.

Election of President

One nomination has been received and was presented: Reza Khoshdel

Reza joined the W.R.C.A. board in 2019 and is currently the Director of Environment and Conservation with a focus on Rouge Park.

The W.R.C.A. Constitution requires a nominee for President to have been on the board for a minimum of one-year to be eligible.

Having received no other nominations, Larry declared that Reza Khoshdel would be acclaimed as President.

Board of Directors

All current members of the board have indicated their willingness to serve another term.
